Pursuant to R.C. 2151.10, 2151.40, and 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$73.50 (Seventy Three Dollars and Fifty Cents) from 1001-007-16-902 to MOUNTSIER, HEATHER, at C/O PROBATE JUVENILE COURT, CHARDON, OH 44024, for employee mileage reimbursement, which the Juvenile Court has determined to be an expenditure for a proper public purpose.
